Program dodjele potpora za održivu obnovu kulturne baštine.pdf	U odnosu na regionalne potpore potrebno je istaknuti da se do 31.12.2021. primjenjuju sljedeći intenziteti: 25% za cijelo područje Republike Hrvatske. Prema karti regionalnih potpora koja će biti u primjeni od 1.1.2022. do 31.12.2027. intenziteti će biti sljedeći: Jadranska Hrvatska 40%, Panonska i Sjeverna Hrvatska 50% i Grad Zagreb 35%. Uz bonuse za male poduzetnike 20% i srednje poduzetnike 10%. U odnosu na iznos potpore ističemo da je se iznos od 1.073.523.670 kn odnosi na ukupan iznos za razdoblje primjene koji se sastoji od nacionalne komponente od 161.028.440 i iznosa iz Europskog fonda za regionalni razvoj od 912.495.120 kn. Nakon inicijalnog Programa potpora SA.42646 prve izmjene registrirala je Europska komisija pod brojem SA.50248
